Bill 3/2007, on the regulation of the registry amendment of the mention relating to the sex of persons:

- Spanish nationality, **of legal age and capacity** ("capacidad de obrar").
- **Medical certificate for the diagnosis of gender dysphoria.**
- **Absence of personality disorders** that could have a determining influence on the diagnosed dysphoria.
- Two-year **medical treatment to accommodate the physical characteristics of the "claimed sex"**.
- Though **genital surgery is not required.**

CURRENT LEGISLATION

Proposal for a Bill on the legal protection of trans people and the right to self-determination of sexual identity and gender expression:

- **Self-determination** of "sexual identity and gender expression".
- With **full legal force in all areas.**
- No physical changes needed (**none**).
- Without any limitation on the basis of **age**, sex, marital status, functional or **psychological diversity**, sexual orientation, socio-cultural or political-administrative situation or any other personal condition.
- **Free access without any screening or scrutiny to all spaces previously segregated by sex.**

IOC Consensus Meeting on Sex Reassignment and Hyperandrogenism November 2015

In this spirit, the IOC Consensus Meeting agreed the following guidelines to be taken into account by sports organisations when determining eligibility to compete in male and female competition:

1. Those who transition from female to male are eligible to compete in the male category without restriction.
2. Those who transition from male to female are eligible to compete in the female category under the following conditions:
 - 2.1. The athlete has declared that her gender identity is female. The declaration cannot be changed, for sporting purposes, for a minimum of four years.
 - 2.2. The athlete must demonstrate that her total testosterone level in serum has been below 10 nmol/L for at least 12 months prior to her first competition (with the requirement for any longer period to be based on a confidential case-by-case evaluation, considering whether or not 12 months is a sufficient length of time to minimize any advantage in women's competition).

More women convicted of sex offences

Record numbers of women are being convicted of sex offences.

The number has doubled in two years with 120 women and girls found guilty of attacks including rape and sexual assault in 2016, according to the latest figures from the Ministry of Justice. That was up from 48 in 2006.

Six females were convicted of rape and four of exposure and voyeurism. Others offences included sex with a child and internet child pornography.

2 - What is the definition of rape?

1. The definition of rape was substantially changed by the Sexual Offences Act 2003, which came into force on 1 May 2004.
2. Offences committed before 1 May 2004 are prosecuted under the Sexual Offences Act 1956. Under the 1956 Act, the statutory definition of rape is any act of non-consensual intercourse by a man with a person, and the victim can be either male or female. Intercourse can be vaginal or anal. It does not include non-consensual oral sex. The courts had defined consent as having its ordinary meaning, and lack of consent could be inferred from the surrounding circumstances, such as submission through fear. It is a defence if the defendant believed that the victim was consenting, even if this belief was unreasonable, and this is a matter of fact for the jury.
3. Offences committed on or after 1 May 2004 are prosecuted under the Sexual Offences Act 2003. The 2003 Act extends the definition of rape to include the penetration by a penis of the vagina, anus or mouth of another person. The 2003 Act also changes the law about consent and belief in consent.

Letting criminals self-identify gender 'putting women at risk'

Male sex offenders can skew crime statistics and put women at risk by claiming to be female when arrested, it has emerged.

Humza Yousaf, the justice secretary, confirmed in parliament yesterday that criminal incidents are tracked according to the self-identified gender of victims, witnesses and suspects. It prompted concerns that Scotland is introducing "self-identification through the back door" by allowing police and courts to record crimes according to the gender suspects feel they are.

Politicians, experts and women's groups have warned that this could distort crime statistics and result in offenders who are male-bodied being placed in female-only refuges, exposing other inmates to danger and upset.

Ms McAlpine, 57, said: "Aside from the statistical corruption, I cannot be the only woman who finds it deeply offensive that male sexual violence can ever be badged as a female crime.

Sheffield woman found with over 1,000 indecent images of children hauled before the court

A Sheffield woman has been hauled before the city's Crown Court after she admitted to possessing over 1,100 indecent images of children, some of which involved kids as young as five.

South Yorkshire Police (SYP) raided the home of Toni Prince, 55, after receiving intelligence which suggested she had been downloading indecent images of children.

Officers seized two laptops and a mobile phone from the home of Prince, a transgender woman whose legal forename is Anthony.

Criminals should not be allowed to choose their gender

Canadian police no longer record the sex of perpetrators and victims.

The government of Canada, through its agency Statistics Canada, has instructed police departments across the country to stop recording the sex of both perpetrators and victims of crime. In place of sex, self-declared gender is now documented.

Statistics Canada offers three gender categories for criminals and victims to choose from: male, female or gender-diverse. This is clearly designed to confuse, as 'male' and 'female' are generally well understood to denote biological sex rather than gender. The Canadian government has effectively redefined what it means to be male and female. A female is now a 'person who publicly expresses as female in their daily life, including at work, while shopping or accessing other services, in their housing environment or in the broader community'. Male has been redefined in the same manner.

The upshot of all this is that if a man who chooses to dress in women's clothing in his 'housing environment' goes on to commit a crime, this cross-dressing behaviour is enough for the crime to be recorded as having been perpetrated by a woman.

Male-Bodied Rapists Are Being Imprisoned With Women. Why Do so Few People Care?

Sex offenders such as Patrick Pearsall and Matthew Harks have been housed in Canadian women's prisons. As has contract killer Fallon Aube, the first male offender (to my knowledge) transferred federally as a result of self-ID. Dangerous offender Adam Laboucan is currently housed in the Fraser Valley Institution for Women in British Columbia. To receive the designation of "dangerous offender" under Canadian law, there must be evidence that the offender has a pattern of brutally violent behavior that is overwhelmingly likely to persist. Laboucan was convicted of sexually assaulting a 3-month old baby, yet he is now living in a women's prison that participates in the Institutional Mother-Child Program, which is run by the federal government "to foster positive relationships between federally incarcerated women and their children by providing a supportive environment that promotes stability and continuity for the mother-child relationship." One feature of the program is that it allows young children to live with their incarcerated mothers in detached buildings referred to as "cottages."

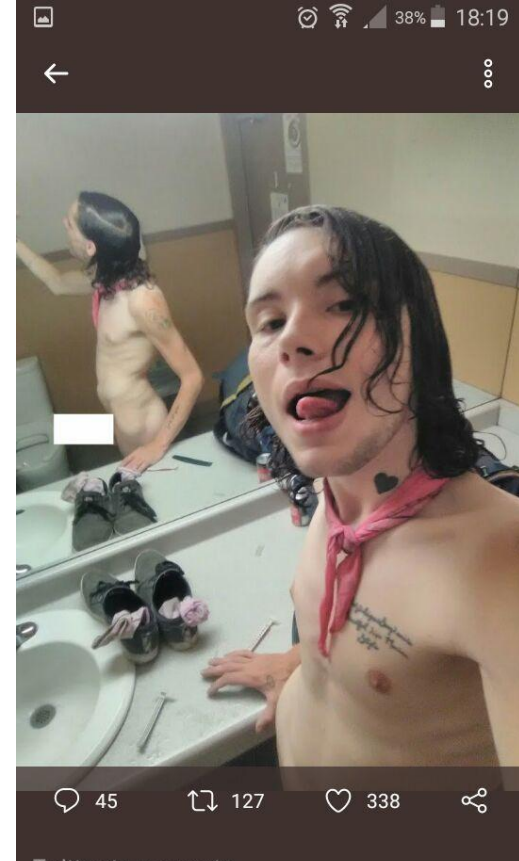

Male Politicians Quietly Eliminated Gender Parity in NY Democratic State Committee

The undoing of 100 years of women's political action

On October 15th, the New York State Democratic Committee quietly voted to amend its State Committee gender parity rule. Previously requiring one man and one woman per district, the rule now requires the two leaders “do not identify as the same gender, unless they both identity[sic] as a non-binary gender.”

The amendment was supported by Nick Rizzo of the 50th District, and Jay Jacobs who represents the 13th AD and serves as Chair of the New York State Democratic Committee.

Together, these three politicians are working to eliminate one of the most important protections for women in New York politics, which was implemented by Elenor Roosevelt and The Leauge of Women Voters in 1920, shortly after women gained the right to vote.

Assistant Secretary and Assistant Treasurer [**are of the opposite gender from**] **do not identify as the same gender as** the Secretary and Treasurer, respectively, **unless both the Secretary and the Assistant Secretary, or both the Treasurer and Assistant Treasurer, identify as a non-binary gender;** and that the officers, as a whole, reflect the diversity of the Democratic Party of New York State.

The amendment was proposed by Emilia Decaudin of the 94th District, a biological male who identifies as female. Decaudin currently represents the 94th along with Christine Robbins, a woman, in accordance with the current version of the rule: one male, one female.

Decaudin has publicly stated an intent to implement the same amendment for District Leadership positions, such as theirs. Following the rollout of such an amendment, Robbins and Decaudin would not be able to serve the district together. If Decaudin is to maintain a leadership position in the 94th when the rule takes effect, Robbins will necessarily be replaced with a male.

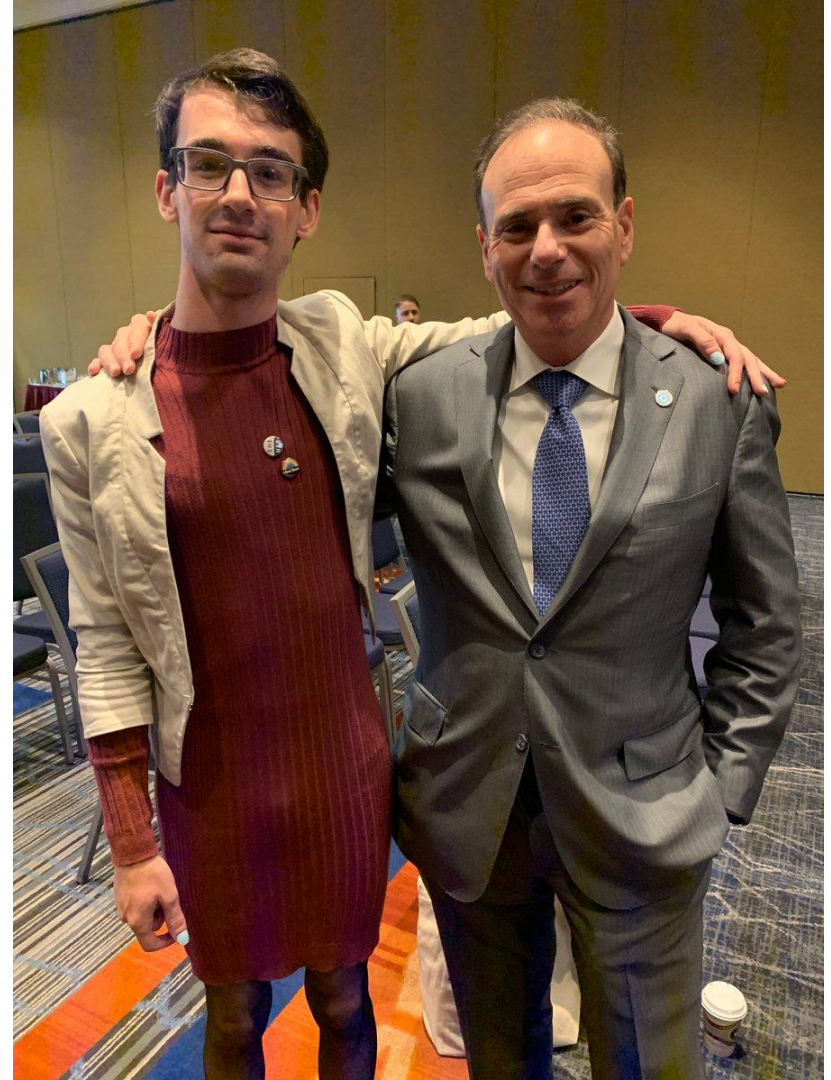

After the event, *The Lesbians Collective* was labelled a “hate group” by the Vancouver Dyke March (August 2018).

Lesbians are being excluded from the Vancouver Dyke March in the name of ‘inclusivity’

Lesbians are being harassed and bullied out of their own spaces and events by trans activists and their allies.

While we were gathering near McSpadden Park, where the march was to begin, we were approached by two members of the Vancouver Dyke March board. They told us that our T-shirts and placards excluded transwomen and since this was an “inclusive march” we would have to remove them if we wanted to participate. We were additionally told that if any of our signs, banners, or t-shirts included **the venus symbol** — representing “woman” — (the two interlocked venus symbols have always meant lesbian) or “XX,” symbolizing the female sex chromosome, we would also have to remove them. We were warned to not touch anyone and keep our hands to ourselves. Nothing was offered in terms of how *our* inclusivity and safety would be protected.

**DECLARATION ON WOMEN'S

(WOMEN'S DECLARATION)**



Women's Declaration

Women's Human Rights Campaign (WHRC) is a group of volunteer women from across the globe dedicated to protecting women's sex-based rights.

The *Declaration on Women's Sex Based Rights* was created by the founders of WHRC to lobby nations to maintain language protecting women and girls on the basis of sex rather than "gender" or "gender identity".

The **Declaration on Women's Sex-Based Rights** seeks to **oppose** the changes being made in the national laws of many countries, following the development of the so-called **Yogyakarta Principles** (named after the Indonesian city where they were signed in 2007), which **replace "sex" by "gender" as a category to be protected by law.**

This unfortunate confusion has been the legal basis for implementing the postulates of the "gender identity" doctrine in regulations that are proving so harmful to women and girls in different countries.

In 2018, **Sheila Jeffreys wrote a critical feminist analysis of the Yogyakarta Principles**, as a reaction to the legislative changes proposed in the United Kingdom to implement "gender self-identification" ("Self-ID").

The Declaration outlines current international laws and policies on women's rights and how they are being threatened by organisations that are trying to change the definition of woman.

Women's rights, set out in the 1979 Convention on the Elimination of all Forms of Discrimination against Women (CEDAW) and subsequent international agreements, **are based on our sex, defined by the UN as "the physical and biological characteristics that distinguish males from females"**.

The Declaration on Women's Sex Based Rights is a statement on the importance of keeping the current sex based definition of woman.

Many women's rights are related to our biologically female bodies e.g. the right to **abortion**, and **maternal rights**. Other women's rights are aimed at **eliminating discrimination against women in public life** e.g. women's rights to education, political representation, work, equal pay. Further women's rights are **to protect us against violence or harmful practices** e.g. **rape, and FGM**.

In recent years some governments have been substituting “gender identity” for biological sex in law and policy, and including men who say they have a female “gender identity” in the word “woman”.

This enables these men to access spaces and services set up for women and girls. This includes **single sex victim support services, single sex sport, women's shortlists designed to increase women's participation in political and public life, scholarships and prizes for women, single sex toilets, changing rooms and sleeping areas** aimed at protecting the safety, privacy and dignity of women and girls.

Using “gender identity” instead of biological sex threatens maternal rights, women's right to assemble and organise without including men, and data collection on violence against women and girls.

Furthermore, **“gender identity” is being used to “transition” girls who do not conform to sex stereotypes.**
